Kid's Summer Camp Participant Registration and Release Form

Registration and Refunds

Registration and payment for the Easely Art Studio's Kid's Summer Camp must be completed and submitted before the first day of camp. Full payment is required at the time of registration to reserve the child's space. Due to limited space, refunds will not be given. Participants may sign up for any or all of the weekly camps. There will be no proration of fees for any days a child participant cannot attend. If absence is known in advance of scheduled Camp week, parent/guardian may elect the day rate of \$70/day instead.

Age Guidelines:

Easely Art Studio's Kid's Summer Camp is for children ages 6 to 8 years and 9 to 12 years, however some exceptions can be made with prior consent of the Camp Coordinator on a case by case scenario. The participants will be divided into two separate groups dependent on age.

Hours of Operation:

Easely Art Studio's Kid's Summer Camp hours are Monday - Friday, 12:00pm - 5:00 pm with a 30 min snack break. You may drop off your child up to 30 min early, with prior consent of the Camp Counselor. Please make sure to coordinate any early drop offs or late pickups, as you could risk dropping off your child before business hours.

Dates for the Summer 2021 camp are:

June 7th - 11th (Ages 6-8)

June 14th - 18th (Ages 9-12)

June 21st - 25th (Ages 6-8)

June 28th - July 2nd (Ages 9-12)

July 12th - 16th (Ages 6-8)

July 19th - 23rd (Ages 9-12)

Pick-up and Drop-Off Procedures:

Children need to arrive between 11:50 am - 12:00 pm and must be picked up between 5:00 - 5:30 pm. Parent/guardian must park their vehicle and walk their child into the Studio and sign the child into Camp for the first day, but can just curbside drop off every day following. The check-in area for Camp will be in the Studio, which is located in the Jordan Landing, next to La Luna and The Puppy Store.

Late Pick-Up Policy:

There will be a late-fee assessed for children who are picked up after 5:30 pm. The late fee is \$5.00 for each 15 min increment after 5:30 pm.

Medical Needs/Allergies:

Easely Art Studio is not permitted to administer medication to program participants. In the event of a medical emergency, Camp staff will contact 911 professionals to administer first aid, CPR, and rescue in the best interest of the child. Parents will be contacted if care is administered. Any allergens or specific medical needs must be described in detail in writing and provided to the Camp Coordinator the day of registration.

Special Circumstances:

Parents and guardians are required to inform the Camp Coordinator in writing of any special circumstances which may affect the child's ability to participate fully and within the guidelines of acceptable behavior, including, but not limited to, any serious behavioral problems or special circumstances regarding psychological, medical, or physical conditions. Once the notice is submitted, a conference may be scheduled with the parent/guardian to discuss the special circumstances and whether the Studio can accommodate the circumstances.

Dress Code:

Children should dress appropriately for the activities scheduled. Easely Art Studio recommends clothing that can get stains and/or other art materials on them. Easely Art Studio will provide aprons for most activities, however some clothing damage may occur. Please have your child dress appropriately for their age group. Clothing that displays drugs, alcohol, tobacco, offensive language, excessive bagginess, or is excessively revealing will not be permitted.

Personal Belongings:

Please put the child's name on any articles of clothing, lunch bags, backpacks, etc. Children should not bring toys, electronic devices, jewelry, money, or any possession of value with them to any of the programs, with the exception of a cellular phone in order to contact their parent/guardian. Cell phones will not be permitted during the activities of the day. Children will be responsible for their belongings, and our Camp is not responsible for any damaged or stolen items.

Lunch and snacks:

You may send your child with a packed lunch or snack to enjoy during our break period (around 2:30pm). Food items should be in a paper, plastic, or reusable bag clearly labeled with the child's name. We will not provide meals for your child for lunch time, and cannot leave the premises to purchase food from nearby restaurants. We will however include 1 snack and 1 water each day with their registration. Your child will receive their complimentary snack and drink in the afternoon each day they attend.

Behavior Management/Discipline Policy:

Easily Art Studio Camp staff will create a fun and safe environment for participants in the program. Praise and positive reinforcement are used as effective methods of behavior management. Children who do not respond to these methods or who are destructive to others or to property will be dealt with in a professional, positive, and timely manner to correct the behavior. The following procedures will be followed for behavior management. All incident reports will be discussed privately with parents/guardians and a copy of each report will be kept on file with the Studio.

1. In the event a child's behavior is a repeated behavior and cannot be corrected by the Camp Staff with a verbal warning or other form of behavior modification, a first incident report will be written to document and correct behavior. A copy of the report will be given to the parent/guardian the same day as the incident. A second incident report will be written if the behavior is repeated by or new behavior problems occur with the same child. This report will follow the same process as the first, but a one day suspension could accompany this report, and no refund will be provided for suspended days. A copy of the report will be given to the parent/guardian the same day as the second incident.

2. A third incident report will be completed using the same process as the first two. The Camp staff will write this report. Staff will provide this report to the parent/guardian. Incident reports will be discussed privately with a parent/guardian by Camp staff and/or Coordinator. Dismissal from a program can occur at this time. **NOTE:** Immediate dismissal from the program can occur at any time given severe circumstances. Refunds for missed days due to a discipline dismissal will not be granted.

In consideration of Easily Art Studio giving my Minor Child(ren) the opportunity to participate in arts and craft activities, I understand that Easily Art Studio assumes no responsibility for any injury to my Minor Child(ren) resulting from his/her/their participation in art activities, using supplies or art materials, and I agree to assume all risk and bear full responsibility (though not likely) for any injury or damage my Minor Child(ren) may suffer while participating in any arts and craft activities. My Minor Child(ren) has/have no physical or mental limitations which would preclude his/her/their safe use of the art materials, craft supplies, or other art mediums and/or I assume all risks that may be created by such limitations. I further certify that neither my Minor Child(ren) nor I am currently mentally impaired or under the influence of drugs or alcohol; and I am otherwise legally competent to understand and enter into this Agreement for and on behalf of my Minor Child(ren). The risks outlined in this Agreement are not exhaustive and I acknowledge that there may be other risks, hazards, and dangers that, based on the circumstances, are integral to arts and crafts.

RELEASE, INDEMNIFICATION AND PROMISE NOT TO SUE

I hereby indemnify, hold harmless and release Easily Art Studio, its shareholders, directors, officials, representatives, agents and employees from any and all loss, claims, damage, or liability which might arise out of my Minor Child(ren)'s participation in the arts and craft activities. This release is binding on his/her/their heirs, assigns and agents. In the event that I file a lawsuit against Easily Art Studio, its shareholders, directors, officials, representatives, agents and employees, I agree to do so solely in the state court located in Salt Lake County, Utah.

FACILITY RULES AND AGREEMENTS

My Minor Child(ren) will comply with ALL Summer Camp rules, both written and as stated to him/her/them by Easely Art Studio during his/her/their participation in arts and craft activities. My Minor Child(ren) will obey the Campstaff in regards to those rules as they affect his/her/their safety, other participants and observers, the property of Easely Art Studio, and all resources used in conjunction with arts and craft activities. My Minor Child(ren) agrees and warrants that he/she/they will inspect each portion and participant of the program in which he/she/they take part and that, if my Minor Child(ren) finds any condition which he/she/they considers to be unacceptable, hazardous, or dangerous, my Minor Child(ren) will notify the Camp staff and refuse to take part in the hazardous activity until the condition has been corrected. My Minor Child(ren) understands that Easely Art Studio reserves the right to refuse or terminate his/her/their participation in arts and craft activities for any nondiscriminatory reason at any time.

I have read this agreement, understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature, and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law on behalf of myself and my Minor Child(ren). I also agree that if any portion of this Agreement is held to be invalid, illegal, or unenforceable, that portion of this Agreement shall be deemed separate, distinct and independent, and shall be ineffective to the extent it (i) invalidates the remaining provisions of this Agreement under applicable law or (ii) affects the legality, validity or enforceability of this Agreement. I certify that I am at least 18 years of age and that no other representations have been made to me that change, alter, or modify anything within this Agreement. Additionally, I give Easely Art Studio permission to use in its marketing materials any picture in which my Minor Child(ren)'s likeness appears unless I notify Easely Art Studio in writing otherwise.

Waivers and Informed Consent:

By signing this form, I, as parent/guardian, permit Easely Art Studio to use pictures of my child(ren) as a program participant in promotional literature, videos, and the Studio website and social media. I understand my child(ren)'s name(s) will not be published. I, as parent/guardian, hereby assume all risks and hazards incidental to the conduct of the activities at Easely Art Studio. My Child is fit for the program(s) in which I have enrolled him/her.

I HERELY RELEASE AND SHALL DEFEND, INDEMNIFY AND HOLD HARMLESS RELEASEES FROM EVERY CLAIM AND ANY LIABILITY THAT I OR MY CHILD MAY ALLEGE AGAINST RELEASEES (including reasonable legal fees and costs) AS A DIRECT OR INDIRECT RESULT OF INJURY OR DEATH TO ME OR MY CHILD BECAUSE OF MY CHILD'S PARTICIPATION IN ANY EASELY ART STUDIO KID'S SUMMER ART CAMP PROGRAMS, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERS TO THE MAXIMUM EXTENT PERMITTED BY LAW. I PROMISE NOT TO SUE RELEASEES ON MY BEHALF OR ON BEHALF OF MY CHILD REGARDING ANY CLAIM ARISING FROM OR RELATED TO MY CHILD'S PARTICIPATION IN ANY EASELY ART STUDIO KID'S SUMMER ART CAMP PROGRAMS. I ACKNOWLEDGE THAT, BY SIGNING THIS DOCUMENT, I AM RELEASING EASELY ART STUDIO, AND THEIR REPRESENTATIVES, AGENTS, EMPLOYEES, VOLUNTEERS, MEMBERS, SPONSORS, PROMOTERS, AND AFFILIATES (COLLECTIVELY "RELEASEES") FROM LIABILITY, AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS. THIS SIGN UP AND RELEASE FORM IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES AND IT

APPLIES TO ALL ACTIVITIES IN WHICH MYCHILD ENGAGES DURING THE SUMMER ART CAMP AT EASELY ART STUDIO,REGARDLESS OF WHETHER SUCH ACTIVITY IS A PART OF A FORMAL PROGRAM. I HAVE READ THIS RELEASE CAREFULLY BEFORE SIGNING. I UNDERSTAND WHAT THIS RELEASE MEANS AND WHAT I AM AGREEING TO BY SIGNING. I understand that no insurance coverage for participants in these activities is provided by Easely Art Studio. By registering for this program, I understand and agree that if a portion of the program is unable to be completed due to unforeseen circumstances under responsibility of the EaselyArt Studio Kid's Summer Art Camp, I will receive a prorated credit on my account for the uncompleted portion of the program. I also understand that norefunds or proration will be given for any other reason.
